Merrett Stierheim, former Miami-Dade County Manager, died July 7, 2024, at the age of 91.

Most of us who worked in South Florida governmental entities admired his accomplishments. He served as City Manager for Clearwater, Miami, and Doral and was the Interim City Manager of Miami Lakes. In addition, he was the County Manager of Pinellas County and Miami-Dade County (twice). He was the Miami-Dade County Superintendent of Schools. He also served as the Women's Tennis Association CEO and Greater Miami Convention & Visitors Bureau CEO. It is no wonder he received the ASPA National Public Service Award in 2003.

I first met Merrett in 1981 when I was a Miami-Dade County Manager intern. One of my cherished memories is a great picture of the interns and Merrett; every time I knew we would be at an event together, I brought it, and he would sign the back of the photograph. It became a great joke between us as to how often I could catch him to sign the photo. I will be happy to share this picture with anyone interested in seeing it.
